Fund objective

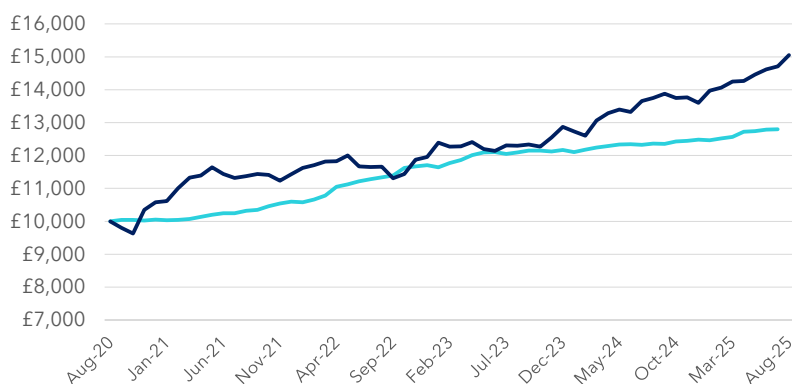
The Fund aims to deliver long term growth over a rolling five-year period in excess of inflation (UK Consumer Price Index).

August Update

Risk assets delivered further gains in August, supported by rising expectations for an interest rate cut in the US and solid quarterly earnings. In developed markets, Japanese equities outperformed, while European and UK shares rose yet lagged global equities. In fixed income, Emerging Market (EM) debt led the gains, helped by a softer US dollar. In sovereigns, US Treasuries performed well while UK Gilts proved a laggard. Elsewhere, US high yield bonds outpaced their European counterparts.

The True Potential Schroders Cautious Fund returned 2.31% (net of fees). The Fund's allocation to gold miners drove performance, with the Schroder ISF Global Gold USD Fund delivering the best returns overall. The Fund's exposure to Japanese shares via the Man GLG Japan CoreAlpha Fund also proved beneficial, as did the allocation to global equities via the Heptagon Kopernik Global Equity Fund and Amundi Global Equity Quality Income Fund. The exposures to EMs also provided a positive contribution, with the Man GLG Asia (Ex-Japan) Fund and Artemis Global Emerging Markets Fund performing well. The allocations to UK equity funds delivered positive returns overall, with the Brickwood UK Value Fund and TM RWC UK Equity Income Fund performing well. In fixed income, the allocation to US Treasuries (sterling hedged) helped performance but exposure to core UK Gilts detracted as UK inflation surprised to the upside. Meanwhile, the alternatives segment outperformed sovereign bonds, with the Montlake Invenomic US Equity Long/Short Fund performing well. A modest exposure to physical gold also proved supportive.

What is the benchmark for this fund?

The benchmark for this fund is Consumer Price Index (UK CPI). The benchmark may be used as a guide to compare and assess the performance of the Fund. The OCF of this fund is currently 1.18%. This means that if you invest £1000 in the fund, you can expect to pay £11.80 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

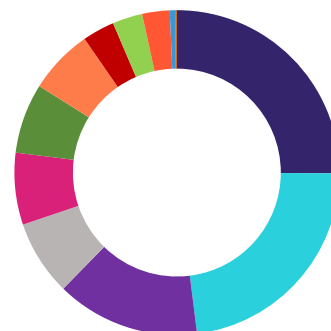

Risk type	Description
