

True Potential Cautious Portfolio

Portfolio Objective

The objective of the True Potential Cautious Portfolio is to provide investors with a way to achieve their investment goals. The Portfolio offers full exposure to different manager styles within the Cautious risk profile. We review the Portfolio monthly and, if necessary, rebalance to the allocation of styles that we believe offers the best opportunity for growth within the Cautious risk profile. The Portfolio aims to produce a higher risk-adjusted outcome at a lower average cost, compared to an equally-weighted model of Cautious funds.

The Cautious Investor may be sensitive to short-term losses. A Cautious Investor's potential aversion to losses could compel them to shift into a more stable investment if significant short-term losses occur. Analysing the risk-return choices available, a Cautious Investor is usually willing to accept somewhat lower returns in order to assure greater safety of his or her investment.

Investment Commentary

The True Potential Cautious Portfolio returned +1.85% in May 2025.

After the turmoil from Trump's tariffs in early April, global equities rebounded in May as Trump backtracked and investors looked ahead to robust expectations for corporate profits. Global equities rose nearly +6%, lifting the year-to-date return to 5.2%. The US was the strongest market, up +6%, boosted by technology companies. Strength was evident across the UK, Europe, Japan, and Emerging Markets, which all advanced by +4-5%.

Corporate bonds provided a positive return following the relief of tariff rollbacks, Global Investment Grade +0.1%, and High Yield +1.7%. Government bonds came under pressure, with 10-year yields rising in the UK, US, and Japan, given concerns of the increased supply of bonds coming to market to support government spending packages. Global government bonds provided a return of +0.2%, whilst Gilts were down -1.2%. GBP strengthened +1.0% against the US Dollar and +0.8% against the EUR, given higher yield differentials.

The strongest performing funds were Growth-Aligned Cautious and Pictet Cautious. They benefited from their larger allocation to equities, as well as their allocations to corporate bonds, particularly High Yield, and a lower US dollar allocation. More challenged managers include Trinity Bridge (formerly Close Brothers), who maintained a lower risk posture. The manager has since been building equity exposure back, buying individual companies that lagged the rally but present strong fundamentals for future returns.

Reflecting improved sentiment on global trade and the economy, select managers who had reduced risk exposure added back into the equity market, funded mainly through US treasury bonds and Gold. During the month we also removed 7IM as a manager, with the proceeds allocated to Growth-Aligned. This was completed through a merger of assets, and therefore, no Portfolio rebalance took place in May.

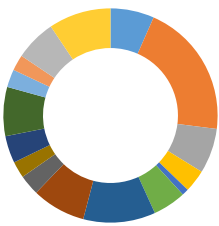

In September 2024, the FCA updated its Packaged Retail Insurance and Investment Products (PRIIPS) guidance on how we disclose costs for closed-ended funds like investment trusts. As a result, some of our fund OCFs (Ongoing Charges Figure) have significantly decreased, reflecting only the costs that directly affect the fund's assets.

What are the fees associated with investing in this Portfolio?

The OCF of this Portfolio is currently 0.78%. This means that if you invest £1000 in the Portfolio, you can expect to pay £7.77 in fees over the course of a year. The fees you pay are pro-rata. If you hold the Portfolio for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk Type	Description
